Schedule

- 9:00 a.m.** Student Arrival at the Main entrance (Grand Revolver). Please go up the escalator to the 3rd floor Volunteer Desk/Atrium Lobby to notify them of your arrival. (This is located to the right at the top of the escalator.) The students will wait in the Atrium Lobby for the Coordinator to pick up them up as a group and move to a designated room.
- 9:00 - 9:30 a.m.** Welcome/ Review of Schedule/ Identification of Nurse that the student is to be paired with
- 9:30 - 1:50 p.m.** Student taken to the unit and introduced to the Nurse Ambassador/ Shadow student with Nurse Ambassador on unit/ Time includes 30 minute lunch. Student receives a \$4.00 lunch voucher.
- 2:00 p.m.** Students return scrubs to Shadow a Nurse Program coordinator/Evaluations/ Student departure

Students will be met by a Shadow a Nurse Coordinator at the **3rd floor Atrium lobby**. Go to the Main Entrance, through the Grand Revolver, up the escalator to the Volunteer desk to the right of the escalator.

After the Welcome and Review of Schedule, the student **will be taken to the units by the Shadow a Nurse Coordinator** and introduced to their Nurse for that day.

Lunch vouchers are provided for the students.

To insure HIPAA and other privacy laws are not violated, I understand Akron Children's Hospital's policy not to share any health information about another person.

By signing this form, I acknowledge that I will keep all health information confidential that I obtain in connection with my Shadow a Nurse experience. This includes information about any medical condition, medical testing, medical treatment or surgery, prescription medications, or any other treatments or procedures related to the health of an individual. In addition, I agree not to use or disclose this information to any person except those persons directly necessary. This includes talking to others about the medical information. If I am not sure whether or not any information is confidential, I agree to ask the Shadow a Nurse Coordinator.

I understand that I am responsible for maintaining the confidentiality of all information related to Akron Children's Hospital. This Agreement prohibits the unauthorized verbal, written or auditory communication of any information about patients, families, physicians, employees and volunteers which is of a medical, personal, or financial nature, including the fact a patient was admitted to the Hospital or to any other Akron Children's Hospital facility.

Driving Directions to the Bowery St. parking deck

From the North: Take I-77 south to the Rt. 59 east exit (21C). Follow Rt. 59 to the Downtown/ Cascade Parking/W. Market St. exit. At the second light, veer right onto Center St. At first light, turn right onto Bowery. The Bowery St. deck is on the left after the first light.

Alternate from the North: (Turnpike, Hudson, Cuyahoga Falls, Silver Lake, Stow): Take Rt. 8 south to the Perkins St./Rt. 59 exit. Turn right onto Perkins Street/Rt. 59. Continue for about one mile. Exit at W. Exchange St./Cedar St. ramp. On the ramp, follow the sign for 59 South/W. Exchange St. Turn left onto Locust St. At first light, veer left onto Center St. At first light, turn right onto Bowery. The Bowery St. deck is on the left after the first light.

From the South: Take I-77* north and exit at Main St./Downtown (22A). Veer right at the split in the ramp and merge with Broadway St. (one way). Follow for about $\frac{3}{4}$ mile toward downtown Akron. Turn left at Exchange St. At third light, turn right on Bowery St. The Bowery St. deck is on the right.

From the East: Take I-76* west and exit at Main St./Downtown (22A). Veer right at the split in the ramp and merge with Broadway St. (one way). Follow for about $\frac{3}{4}$ mile toward downtown Akron. Turn left at Exchange St. At third light, turn right on Bowery St. The Bowery St. deck is on the right.

From the West: Take I-76 east to the Rt. 59 east exit (21C). Follow Rt. 59 to the Downtown/ Cascade Parking/W. Market St. exit. At the second light, veer right onto Center St. At first light, turn right onto Bowery. The Bowery St. deck is on the left after the first light.

Driving Directions to the Locust St. parking deck

From the North: Take I-77 south to the Rt. 59 east exit (21C). Follow Rt. 59 to the Downtown/ Cascade Parking/W. Market St. exit. At the second light, make sharp right onto Locust St. The Locust St. deck is on the right after the stop sign.

Alternate from the North: (Turnpike, Hudson, Cuyahoga Falls, Silver Lake, Stow): Take Rt. 8 south to the Perkins St./Rt. 59 exit. Turn right onto Perkins Street/Rt. 59. Continue for about one mile. Exit at W. Exchange St./Cedar St. ramp. On the ramp, follow the sign for 59 South/W. Exchange St. Turn left onto Locust St. At first light, veer right to continue on Locust St. The Locust St. deck is on the right after the stop sign.

From the South: Take I-77* north and exit at Main St./Downtown (22A). Veer right at the split in the ramp and merge with Broadway St. (one way). Follow for about $\frac{3}{4}$ mile toward downtown Akron. Turn left at Exchange St. At fourth light, turn right on Locust St. The Locust St. deck is on the left.

From the East: Take I-76* west and exit at Main St./Downtown (22A). Veer right at the split in the ramp and merge with Broadway St. (one way). Follow for about $\frac{3}{4}$ mile toward downtown Akron. Turn left at Exchange St. At fourth light, turn right on Locust St. The Locust St. deck is on the left.

From the West: Take I-76 east to the Rt. 59 east exit (21C). Follow Rt. 59 to the Downtown/ Cascade Parking/W. Market St. exit. At the second light, make sharp right onto Locust St. The Locust St. deck is on the right after the stop sign.

**I-77 north becomes I-77 north/I-76 west at the central interchange. When driving north, I-77 north becomes Rte 8 north. I-76 west becomes I-76 west/I-77 north at the central interchange.*
