From the West via I-90:

Exit West 25th Street. Turn right and proceed to MetroHealth Drive. Left on MetroHealth Drive.

From I-71 North or South:

Exit West 25th Street. Left on West 25th Street to MetroHealth Drive. Right on MetroHealth Drive.

From the South via I-77:

Take I-490 west to I-71 south. Exit West 25th Street. Left on West 25th Street to MetroHealth Drive. Right on MetroHealth Drive.

From the South via 176 North (Jennings Freeway):

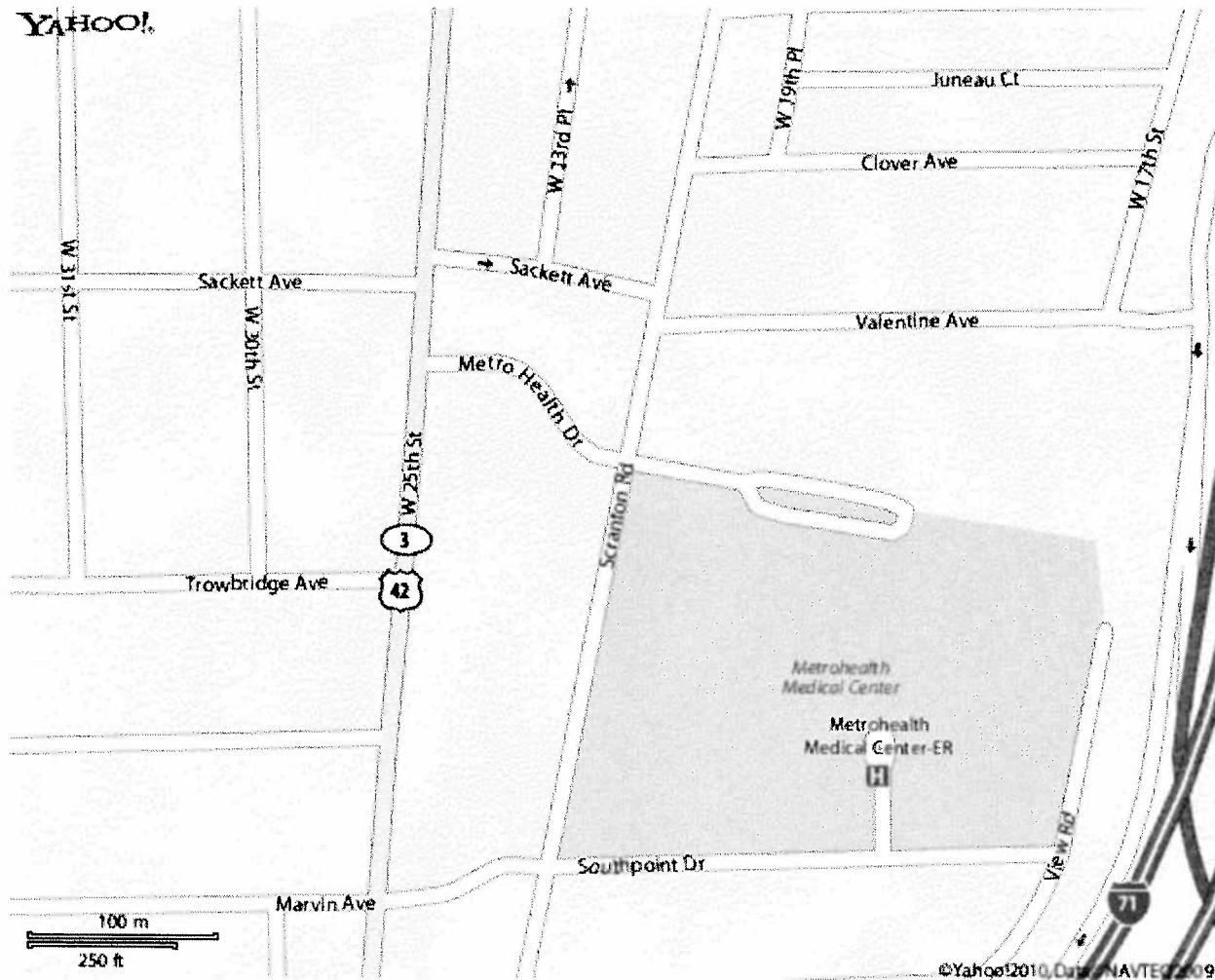
Take I-480 west to Route 176 north (Jennings Freeway). Exit at West 14th Street and follow the signs to I-71 south. Follow above directions for I-71.

From the West via the Ohio Turnpike:

Take exit 151 to I-480 east to I-71 north and follow above directions for I-71.

From the East via the Ohio Turnpike:

Take exit 173 to I-480 west to I-77 north and follow above directions for I-77.
